That the bid of \$351,212.00 by MONARCH CONSTRUCTION OF ORANGE, a partnership, for the CONSTRUCTION OF WATER MAIN REPLACEMENT GROUP 421 in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. A-00061.
2. That the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$68,000.00 within Water Revenue Fund 41502 from Water Unallocated Reserve (70679) to Annual Allocation Main Replacement (CIP 73-083).
3. That the expenditure of \$68,000.00 from Water Revenue Fund 41502 is hereby authorized to supplement Resolution No. 251629, adopted April 21, 1980.
