Ruth C. Herring	City Attorney	\$1,000	Ms. Herring is an Intermediate Typist in the Criminal Division. She suggested that the filing of formal complaints on licensing traffic tickets be eliminated. This is expected to save in excess of \$26,000 annually in processing costs.
Jim Toci	General Services	\$ 505	Mr. Toci is an Electrical Engineer in the Communications and Electrical Division. He suggested that the Parking Company of America be billed for parking lot lighting at a leased facility. One year's increase in revenue is \$5,053.
