

RESOLUTION NO. R- 252124Adopted on JUN 24 1980

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Susan E. Roos	Police	\$125	Ms. Roos is a Senior Clerk in the Support Services Bureau. She suggested that Accident Report jackets be reused. This is expected to save \$920 annually in printing costs. This is a partial award pending a final 12-month review.
Billy E. Davis	Fire	\$100	Mr. Davis is an Engineer in the Equipment Maintenance and Supply Bureau. He suggested that a purchase order for ninety non-OSHA approved helmets be cancelled. This was considered to be a significant safety contribution.
Claire S. Steinberger	Financial Management	\$100	Ms. Steinberger is an Intermediate Stenographer in Economic Research and Analysis. She suggested that the location of property tags on office equipment be standardized. Although savings were impossible to calculate, this was considered to be a significant operational improvement.
Susan M. Gonzales	Park and Recreation	\$ 90	Ms. Gonzales is a Gardener Supervisor in the Park Division. One year ago she earned a partial award of \$90 for her suggestion to change the procedure for trash pick-up at the Blacks Beach glider port. One year's experience has shown a savings of \$1,779. This is the remainder of her award.
John A. Baker	General Services	\$ 80	Mr. Baker is an Equipment Mechanic in the Equipment Division. One year ago he earned a partial award of \$80 for his suggestion to install a grease fitting on the cap of trash packer axles. One year's experience has shown a savings of \$1,610 in maintenance costs. This is the remainder of his award.
