WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Robert C. Nightingale	Planning	\$50	Mr. Nightingale is a Zoning Representative in the Operations Division. One year ago he suggested that swimming pool applications and plans no longer be sent to Zoning for approval. One year's experience has shown a savings of \$1,060 in processing costs. This is the remainder of his award.
William C. Adams	Fire	\$50	Mr. Adams is an Engineer in the Equipment Maintenance and Supply Bureau. He suggested that acid etchers be purchased to identify tools. Savings could not be identified. This was considered to be a significant operational improvement.
Lenn D. Carty	General Services	\$35	Mr. Carty is an Equipment Mechanic in the Equipment Division. He suggested that an additional ground wire be provided for refuse packer electrical clutches. Savings could not be determined. This was considered to be a significant safety improvement.
Jarone Porter	Water Utilities	\$25	Mr. Porter is a Utility Worker I in the Quality Division. He suggested that a two-piece cover be constructed for dump manholes at Pump Stations 1 and 2. Savings could not be calculated. This was considered to be a significant safety improvement.
James L. Strawn	Fire	\$25	Mr. Strawn is a Fire Fighter in the Support Services Bureau. He suggested that a block of styrofoam be placed in first aid kits for used needle disposal. Savings could not be calculated. This was considered to be a significant safety improvement.
