She suggested that a scheduled meeting board be displayed on the Second Floor of the City Administration Building. Savings could not be calculated. This was considered to be a significant operational improvement.
Herb M. Yaklin	Park and Recreation	\$25	Mr. Yaklin is a Utility Worker I in the Park Division. He suggested that a back-up alarm be installed on equipment #9029. Savings could not be calculated. This was considered to be a significant safety improvement.
Daniel D. Vejtasa	Fire	\$20	Mr. Vejtasa is an Engineer in the Equipment Maintenance and Supply Bureau. He suggested that a work order slip be used to record areas of vehicle deficiency. Savings could not be calculated. This was considered to be a significant operational improvement.
Priscilla C. Jordan	Personnel	\$20	Ms. Jordan is a Senior Proctor in the Recruiting and Examining Section. She suggested that Police Officer Recruit written and physical abilities performance exams be given at the same location and the same date. Savings could not be calculated. This was considered to be a significant operational improvement.
