WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Rolando B. Pritchard	Police	\$20	Mr. Pritchard is a Field Representative in the Support Services Bureau. He suggested that a form be used to notify City departments of abandoned traffic devices. Savings could not be calculated. This was considered to be a significant operational improvement.
Myrna F. Choate	Risk Management	\$20	Ms. Choate is an Administrative Aide II in the Group Health and Life Insurance Program. She suggested that a memorandum be sent to all department heads reminding them of their responsibility of attesting to the eligibility of suggesters. Savings could not be calculated. This was considered to be a significant operational improvement.
W. Bronson Rideout	Building Inspection	\$20	Mr. Rideout is an Associate Structural Engineer in the Structural Plan Check and Permit Issuance Program. He suggested that a list be established indicating which plan check engineers are familiar with particular chain plans. This is expected to save \$144 annually in processing costs. This is a partial award pending a final 12-month review.
Susan D. Lowe	Fire	\$15	Ms. Lowe is a Dispatch Clerk in the Fire Suppression Bureau. One year ago she earned a \$15 award for her suggestion to replace glass console tops with tops made of plexiglas. One year's experience has shown an increased volume of usage, greater safety of operation, and a savings of \$69. This is the remainder of her award.
