WHEREAS, the City Council adopted Ordinance No. 15268 (New Series) on May 27, 1980, establishing a schedule of compensation for Officers and Employees of The City of San Diego for fiscal year 1981; and

WHEREAS, said ordinance established the appropriate ranges for enumerated personnel; and

WHEREAS, it is the responsibility of the City Council to identify within those established ranges the appropriate step for those officers whose compensation is determined and set by the legislative body; and

WHEREAS, this Council has received and evaluated compensation data in regard to comparative positions throughout California; and

WHEREAS, having analyzed said data, it is now necessary and appropriate to identify those steps, within range, for those certain positions at which compensation for fiscal year 1981 shall be set; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the salary rate steps for the following named positions for fiscal year 1981 be and they are hereby set as follows:

City Manager	05.0Z
City Attorney	05.0P
City Auditor and Comptroller	04.0Q
Planning Director	04.0Q
City Clerk	03.0G

BE IT FURTHER RESOLVED, that the City Attorney be and he is hereby directed to bring before the Council an amendment to Exhibit A to Ordinance No. 12568 (New Series) to truncate the Executive Salary Table, Rate 05.0.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby directed to make necessary and appropriate adjustments to the pay rate level of the City Manager position upon the effective date of the above amended executive salary table so that the position is placed at step 05.0W.

BE IT FURTHER RESOLVED, that the City Attorney be and he is hereby directed to include within the Annual Appropriation Ordinance for fiscal year 1981 reference of and authorization for this action and further adjustment upon the effective date of the amendment to Ordinance No. 15268 (New Series).
