1. That the bid of \$169,879.25 by R.E. HAZARD CONTRACTING CO., a corporation, for THE IMPROVEMENT OF MARKET STREET AND ROUTE 15 S.W. OFF-RAMP in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. A-00077.
2. That the expenditure of \$245,400.00 from CIP 52-063.8 to include \$68,000.00 from Fund 30219, \$113,145.00 from Fund 30245, and \$64,255.00 from Trust Fund 63021 of the City of San Diego is hereby authorized solely and exclusively for providing funds for said project and related costs.
3. That the City Auditor and Comptroller is hereby authorized to transfer \$19,955.00 excess budgeted funds to the Capital Outlay Reserve, 90-245.
