BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$61,550.73 by D & H PERRY, INC., dba PERRY ELECTRIC, a corporation, for CONSTRUCTION OF TRAFFIC SIGNAL AND STREET LIGHTING SYSTEMS ON GENESEE AVENUE AT UNIVERSITY CITY HIGH SCHOOL AND MEDIAN IMPROVEMNTS in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the specifications on file in the office of the City Clerk as Document No. A-00097.
2. That the contribution of \$25,000.00 from San Diego City Schools to be used for the above purpose is hereby accepted.
3. That the expenditure not to exceed \$79,100.00, to include \$54,100.00 from Gas Tax Fund 30219, CIP 62-125 and \$25,000.00 from the Trust Fund No. 63021 of the City of San Diego is hereby authorized solely and exclusively for providing funds for said project and related costs.
4. That the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$4,500.00 from Capital Outlay Fund 30245, CIP No. 62-125 to the appropriate reserve.
