

That the petition for the improvement of 58TH STREET (EASTERLY SIDE) between Skyline Drive and Churchward Street, under the provisions of the Improvement Act of (1914) consisting of one sheet and filed under Document No. D-02330-1, is hereby granted.

BE IT FURTHER RESOLVED, that the City Manager be, and he is hereby directed to prepare plans, drawings, typical cross-sections, profiles and specifications for the improvement of 58TH STREET (EASTERLY SIDE) between Skyline Drive and Churchward Street, in the City of San Diego, by grading, paving, installation of curbs, gutters, sidewalks and the necessary right-of-way, together with estimates of the costs and expenses of such work and to furnish this Council with a description of the district to be included in the assessment for the work and improvements hereinabove mentioned.
