
Adopted on JUN 30 1980

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of those deeds of STAR VENTURE CORPORATION, a California corporation, executed in favor of The City of San Diego, bearing date of May 19, 1980, conveying to said City an easement for public street purposes over, along and across that portion of Lot 26 in Block 2 of Cullens Westland Terrace, and relinquishing abutters right of access to that portion of Lot 26 in Block 2 of Cullens Westland Terrace, as more particularly described in those deeds, be, and the same is hereby approved; and the land therein conveyed for a public street is hereby dedicated as and for a public street, and the same is hereby named BOUNDARY STREET.
