

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that Street Easement Deed of NAUTILUS INVESTMENT COMPANY, INC., a California corporation, executed in favor of The City of San Diego, bearing date of April 24, 1980, conveying to said City the permanent easement and right-of-way for a public street and incidents thereto, over, under, upon, along and across all those portions of Lots 15, 16, 17, 18 and 19 in Block 7 of Swan's Addition, as more particularly described in that deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named 47TH STREET.

That the City Clerk is hereby authorized and directed to cause that deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
