

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with BLACK AND VEATCH for engineering services in connection with an Industrial Pretreatment Program for the South Bay Wastewater System and related facilities at a cost not to exceed \$188,684, under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. RR-252165.

BE IT FURTHER RESOLVED, that the City Auditor & Comptroller is hereby authorized to transfer within Sewer Revenue Fund 41506 the sum of \$188,684 from the Unallocated Reserve (70697) to Industrial Waste Control (70215) solely and exclusively for the above services.
