That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, Amendment No. 1 to Task Order No. 8 of the Agreement with CH₂M HILL CALIFORNIA, INC., LOWRY AND ASSOCIATES, BOYLE ENGINEERING CORPORATION, JOHN CAROLLO ENGINEERING, and RICK ENGINEERING COMPANY, a Joint Venture, in connection with the South Bay Wastewater System and related facilities, by expanding the public participation program to include public participation studies to establish an industrial pretreatment program and a nonindustrial source control program at a cost not to exceed \$37,869, under the terms and conditions set forth in Amendment No. 1 to Task Order No. 8, on file in the office of the City Clerk as Document No. R.R- 252168.
