That Change Order No. 3, dated May 1, 1980, heretofore filed with the City Clerk of said City as Document No. RR-252169, issued in connection with the contract between The City of San Diego and Viewland Construction Company for construction of EXTENSION OF STORM DRAIN SOUTH OF OAKRIDGE ROAD BETWEEN STRATUS COURT AND CIBOLA ROAD, said contract having been filed in the office of the City Clerk as Document No. 766423, be and the same is hereby approved; and the changes therein set forth, amounting to a net increase in the contract price of \$3,964.58, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the City Auditor is hereby authorized to transfer the sum of \$7,500 from Disaster Assistance Fund 39024 to Extension of Oakridge Storm Drain Project (CIP 11-171), solely and exclusively for the above project.
