

RESOLUTION No. RL-252216 (R.80-2418)

Adopted on JUL 1 1980

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized and empowered to enter into an Agreement, for and on behalf of The City of San Diego, with the SAN DIEGO COUNTY LOCAL DEVELOPMENT CORPORATION for specified economic development services to be provided through the San Diego Local Development Project, under the terms and conditions of that Agreement on file in the office of the City Clerk as Document No. RL-252216.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller is hereby authorized to transfer the sum of \$29,400 from Fund 18516, Dept. 5969, Org. 6901 (University Avenue Neighborhood Business Revitalization), to Fund 18516, Dept. 5969, Org. 6902 (Local Development Corp.).

BE IT FURTHER RESOLVED, that the transfer of not to exceed \$15,000 from the San Diego Local Development Project Fund 18516, Dept. 5969, Org. 6902 to Fund 18516, Dept. 5969, Org. 6904, is hereby approved.

BE IT FURTHER RESOLVED, that the expenditure of not to exceed \$389,400 from Fund 18516 for the above services, including \$374,400 for the services specified in the above Agreement for economic development services, and \$15,000 for auditing and monitoring services, is hereby authorized and approved.
