as follows:



SCHOETTNER, a Licensed Land Surveyor, entitled "TERRACE GREEN UNIT NO. 4 Being a subdivision of Parcel 3 of Parcel Map No. 4946, in the City of San Diego, County of San Diego, State of California, filed in the office of the County Recorder of said County July 22, 1976.," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map.

BE IT FURTHER RESOLVED, that said Council hereby acknowledges receipt of assurance from the subdivider, TREETOPS UNLIMITED, a joint venture, that said subdivider will comply with the Affirmative Marketing Program as outlined in Document No. 757438, on file in the office of the City Clerk, and in reliance on said assurance does hereby accept the final map of TERRACE GREEN UNIT NO. 4.
