- 2. That the City reserves an easement for sewer purposes on the southerly 145 feet of the alley in Block 74 of City Heights, Amended Map No. 1007.
- 3. That the City Clerk shall cause a certified copy of this resolution, with drawing, attested by him under seal, to be recorded in the office of the County Recorder.
