

RESOLUTION No. R-252256 (R-80-2500)

Adopted on JUL 14 1980

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of those Street and Drainage Easement Deeds of CHARLES B. KENDALL, an individual, executed in favor of The City of San Diego, bearing date of May 22, 1980, conveying to said City easements for storm drain facilities and public street purposes, over, along and across that portion of Lot 4 of Park Santa Fe, Unit No. 2, Map 9121, as more particularly described in those deeds, be, and the same is hereby approved; and the land therein conveyed for public street purposes is hereby dedicated as and for a public street, and the same is hereby named SANTA FE STREET.

That the City Clerk is hereby authorized and directed to cause said deeds and a certified copy of this resolution attested by him under seal to be recorded in the office of the County Recorder.
