

RESOLUTION NO. R- 252257 (R.80-2501)

WHEREAS, there were relinquished to The City of San Diego certain abutter's rights of access in and to SANTA FE STREET from Lot 4 of Park Santa Fe, Unit No.2, Map 9121, filed in the office of the County Recorder; and

WHEREAS, CHARLES B. KENDALL, an individual, has requested that the City revest these abutter's rights of access in the property to allow better utilization of the land; and

WHEREAS, said abutter's rights of access are no longer needed by the City and should be revested in the property; and

WHEREAS, CHARLES B. KENDALL has tendered a deed relinquishing access rights in and to SANTA FE STREET from Lot 4 of Park Santa Fe, Unit No. 2, Map 9121, in exchange for City's revestment of abutter's rights of access in and to SANTA FE STREET from Lot 4 of Park Santa Fe, Unit No. 2, Map 9121; and

WHEREAS, the values of the rights to be exchanged are approximately equal; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RR-252257-1, quitclaiming to CHARLES B. KENDALL, an individual, the revestment of those abutter's

rights of access in and to SANTA FE STREET from Lot 4 of Park Santa Fe, Unit No. 2, Map 9121, as more particularly described in said quitclaim deed.

2. That the acceptance of a deed, executed by CHARLES B. KENDALL, an individual, relinquishing to The City of San Diego, access rights in and to SANTA FE STREET from Lot 4 of Park Santa Fe, Unit No. 2, Map 9121, as more particularly described in said deed, be, and is hereby approved.

3. That the City Clerk of said City be, and he is hereby authorized and directed to deliver said deeds and a certified copy of this resolution to the Engineering and Development Department for further handling.
