WHEREAS, the City has completed the third year of a study of criminal activities within The City of San Diego entitled, "Integrated Criminal Apprehension Program" funded by a grant from the Law Enforcement Assistance Administration (LEAA), as authorized by Council Resolution No. 222714, adopted January 29, 1979; and

WHEREAS, the City desires to continue the crime analysis activities which were conducted by the San Diego Police Department pursuant to the grant; and

WHEREAS, federal grant monies are no longer available to fund these activities; and

WHEREAS, continuing these activities requires the extension of the personal services contracts with those independent contractors who have been involved with this study under the grant funding; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager be, and he is hereby authorized to implement, for and on behalf of said City, a Crime Analysis Program to be administered through the San Diego Police Department; and

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute, for and on behalf of said City, first amendments to eleven personal services contracts; said first amendments are on file in the office of the City Clerk as Document Nos. 767858, 767859, 767860, 767862, 767863, 767864, 767865, 767866, 767867, 767868, 767861

BE IT FURTHER RESOLVED, that the expenditure of \$227,656 from the General Fund, of The City of San Diego, be hereby authorized, solely and exclusively for the above-stated purpose.
