A RESOLUTION OF THE CITY COUNCIL AUTHORIZING INCLUSION OF PROJECT NO. 34-044, SAN DIEGO STADIUM ADDITION, IN THE FISCAL YEAR 1981 CAPITAL IMPROVEMENTS PROGRAM; AUTHORIZING THE TRANSFER OF FUNDS AND AUTHORIZING \$10,000 FOR ARCHITECTURAL SERVICES FOR THE ABOVE PROJECT.

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. The Fiscal Year 1981 Capital Improvements Program shall include Project No. 34-044 entitled "San Diego Stadium Addition" to provide for the expansion of the Stadium by from 3,500 to 4,500 seats including 1,000 seats in approximately sixty (60) sky boxes.

2. The sum of \$10,000 is hereby authorized to be transferred from Capital Outlay Fund Unallocated Reserve (CIP 90-245) to CIP 34-044, San Diego Stadium Addition.

3. The sum of \$10,000 is hereby authorized to be expended out of Capital Outlay Fund 30245 for architectural services related to the aforementioned Project No. 34-044.
