BE IT RESOLVED, by the Council of The City of San Diego as follows:

- 1. The Fiscal Year 1981 Capital Improvements Program shall include Project No. 34-044 entitled "San Diego Stadium Addition" to provide for the expansion of the Stadium by from 3,500 to 4,500 seats including 1,000 seats in approximately sixty (60) sky boxes.
- 2. The sum of \$10,000 is hereby authorized to be transferred from Capital Outlay Fund Unallocated Reserve (CIP 90-245) to CIP 34-044, San Diego Stadium Addition.
- 3. The sum of \$10,000 is hereby authorized to be expended out of Capital Outlay Fund 30245 for architectural services related to the aforementioned Project No. 34-044.
