BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. GRAYBAR ELECTRIC COMPANY, INC., 2. ARC-LECTRIC, and 3. COUNTY WHOLESALE ELECTRIC CO. are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of ELECTRICAL MAINTENANCE AND REPAIR MATERIALS as may be required for a period of one (1) year beginning July 1, 1980 through June 30, 1981 per prices on file in the Purchasing Department as follows:

1. GRAYBAR ELECTRIC COMPANY, INC., for Section I (Connectors, Boxes and Miscellaneous); terms 2% 20 days, plus sales tax, with an option to renew the contract for an additional one (1) year period.
2. ARC-LECTRIC, for Sections II and III (Wire; and Conduit, Tubing and Accessories); terms 2% 30 days, plus sales tax, with a potential price escalation of 15% during the contract year for Section II only, and with an option to renew the contract for an additional one (1) year period.
3. COUNTY WHOLESALE ELECTRIC CO., for Section IV (Ballasts, Terminals, Fuses, Wire-mold & Fittings); terms 2% 20 days, plus sales tax.
