BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible and reliable bidder for

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$109,953.00 from PSD Fund 11341, \$8,047.00 from PSD Fund 14341, \$94,453.00 from PSD Fund 14382 and \$20,000.00 from Capital Outlay Fund 30245, CIP 23-275 Grantville Neighborhood Park of the City of San Diego is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
