City of San Diego, County of San Diego, State of California,

Book 8, Page 36 et seq. of Lis Pendens, as filed in the  
office of the County Recorder of San Diego County, together  
with that portion of the east ten feet of Florida Street  
as closed and vacated to public use, lying west of and  
adjoining the land above described," is made in the manner  
and form prescribed by law and conforms to the surrounding  
surveys; that said map and the subdivision of land shown  
thereon is hereby approved and accepted.
