BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the petition for the improvement of the ALLEY IN BLOCK 30, DEL MAR HEIGHTS (between Pine Needles Drive and Condesa Drive and Del Mar Heights Road and Cordero Road), under the provisions of the Improvement Act of 1911, consisting of two sheets and filed under Document No. D-02221-1, is hereby granted.

BE IT FURTHER RESOLVED, that the City Manager be, and he is hereby directed to prepare plans, drawings, typical cross-sections, profiles and specifications for the improvement of the ALLEY IN BLOCK 30, DEL MAR HEIGHTS (between Pine Needles Drive and Condesa Drive and Del Mar Heights Road and Cordero Road), in the City of San Diego, by the acquisition of a storm drain easement, construction of the storm drain and grading and paving, together with estimates of the costs and expenses of such work and to furnish this Council with a description of the district to be included in the assessment for the work and improvements hereinabove mentioned.
