


RESOLUTION No. R- 252296 (R-81-24 )

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby directed to prepare plans, drawings, typical cross-sections, profiles and specifications for the improvement of the ALLEY IN BLOCK 35, DEL MAR HEIGHTS (between Cordero Road and Pinar Place and Pine Needles Drive to approximately 364 feet westerly), in the City of San Diego, by the acquisition of a storm drain easement, construction of the storm drain and grading and paving, together with estimates of the costs and expenses of such work and to furnish this Council with a description of the district to be included in the assessment for the work and improvements hereinabove mentioned.
