

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with KERCHEVAL AND ASSOCIATES, a California corporation, to provide professional engineering services for design of improvements for streets and alleys in Community Development Block Grant (CDBG) target areas, under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. RR-252302.

BE IT FURTHER RESOLVED, that the expenditure of \$69,000 from CIP No. 52-285, Streets and Alleys Improvements in CDGB Target Areas, Fund No. 18516, and \$11,000 from CIP No. 44-001, Annual Allocation, Main Replacements, Fund No. 41506 is hereby authorized, solely and exclusively for the above purpose.
