That Change Order No. 1, dated March 31, 1980, heretofore filed with the City Clerk of said City as Document No. RR- 252310, issued in connection with the contract between The City of San Diego and MACO SERVICES, INC. for construction of street lighting systems on Camino Del Rio South between Scheidler Way and Fairmount Avenue, said contract having been filed in the office of the City Clerk as Document No. 760610, be and the same is hereby approved; and the changes therein set forth, amounting to a net increase in the contract price of \$1,672.98, be and the same are hereby approved.

2. That Resolution No. 218712 be and it is hereby rescinded.

3. That the expenditure of \$7,028.81 is hereby authorized from Nondepartmental Expenditure Budget (Reimbursement to Capital Outlay Engineering Revolving Fund Program) solely and exclusively for this purpose and related costs.
