WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Ben D. Romero, Jr.	Water Utilities	\$415	One year ago, Mr. Romero earned a partial award of \$410 for his suggestion to install anti-rotating devices on sewer pumps at Pump Station 77. One year's experience has shown a total savings of \$8,252. This is the remainder of his award.
Linda E. Logan	City Attorney	\$410	Ms. Logan is an Intermediate Typist in the Criminal Division. She developed a simplified method of purging cards and cases. The estimated annual savings in clerical costs are \$2,740. This is a partial award pending a final 12-month review.
Martin J. Desmond	Engineering and Development	\$375	Mr. Desmond is an Associate Traffic Engineer. Through his individual effort, he convinced the San Diego Gas and Electric Company to stop charging the City for the installation of secondary transformers at signalized intersections. Savings to date are \$1,256. This is a partial award pending a final 12-month review.
Richard J. Hunt Eileen Jensen	Water Utilities	\$290	One year ago, Ms. Jensen and Mr. Hunt earned a \$290 award with their suggestion to have the Fire Department notify the Utilities Billing Section of new fire services inspected. One year's experience has shown a total savings of \$5,788. This is the remainder of their award.
Thomas E. Trainor	Building Inspection	\$270	Mr. Trainor is an Electrical Inspector Supervisor. He suggested that the aisle width on the third floor of the City Operations Building be reduced to increase the available office space. The estimated savings in rental costs are \$1,800. This is a partial award pending a final 12-month review.
