WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Desmond P. Marmion Hollis L. Pleasant	General Services	\$265	Mr. Marmion and Mr. Pleasant are Utility Supervisors in the Solid Waste Division. They suggested that a gradall be used to remove trash from inoperative refuse vehicles. The estimated first year's savings as a result of this idea are \$1,766. This is a partial award pending a final 12-month review.
Robert G. Wielage	Water Utilities	\$200	Mr. Wielage is a Waste Water Plant Lead Operator in the Quality Division. He developed an on-site training program for Operators and Operator Trainees. Savings could not be calculated, but this was considered to be a significant operational improvement.
Allen Holden, Jr.	Engineering and Development	\$160	Mr. Holden is an Associate Traffic Engineer. He developed a computer program to summarize manually prepared reports. First year's savings are estimated at \$525.
Albert L. Brown Jack A. Mead	Park and Recreation	\$160	Mr. Brown and Mr. Mead are Utility Workers in the Aquatics Division. They constructed a tool for the removal of the seal plate on Gurman Rupp pumps. This is expected to save \$1,080 in maintenance costs in the first year of use. This is a partial award pending a final 12-month review.
Michael H. Hix	Engineering and Development	\$150	Mr. Hix is an Assistant Traffic Engineer. He developed a simplified travel forecasting process. This is expected to save \$3,151 annually. This is a partial award pending a final 12-month review.
