

RESOLUTION NO. R-252725Adopted on JUL 22 1980

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Frank C. Welsch	Water Utilities	\$100	Mr. Welsch is a Plant Maintenance Mechanic in the Quality Division. He suggested that a sump hole be drilled and a sump pump be installed at a problem area at Pump Station 2. This is expected to save \$2,008 in maintenance costs. This is a partial award pending a final 12-month review.
Lee R. Noorda	Property	\$ 60	Mr. Noorda is an Electrician at San Diego Stadium. He suggested that the laundry service for sheets and pillow cases at the Stadium be replaced with disposable paper items. Savings per year are \$200.
Tony C. Zepeda	General Services	\$ 60	Mr. Zepeda is a Carpenter in the Buildings Division. He suggested that hinges where pins have been vandalized be reused. This saves \$200 annually in material costs.
Robert C. Frajman	General Services	\$ 50	Mr. Frajman is an Electrician in the Communications and Electrical Division. He suggested that operating platforms with ladders be installed on discharge valves at Pump Stations 1 and 2. Savings could not be calculated, but this was considered to be a significant safety improvement.
Duane A. Schaper	Water Utilities	\$ 50	Mr. Schaper is an Equipment Technician II in the Quality Division. He suggested that a jig be fabricated to exercise valves. Savings could not be calculated, but this was considered to be a significant operational improvement.
