WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller i. hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Roy C. Wamback	General Services	\$ 45	Mr. Wamback is a Custodian II in the Buildings Division. He suggested that coveralls be purchased and laundered by City staff rather than contracting for service. Estimated annual savings are \$451.
Wayne L. Ramsey	City Treasurer	\$ 45	Mr. Ramsey suggested that a telephone answering machine be purchased to replace the leased machine currently in use. Annual savings are expected to be \$441.
Allen Holden, Jr.	Engineering and Development	\$ 45	Mr. Holden is an Associate Traffic Engineer. He suggested that a unified filing system be established for transportation analysis and transportation development. Estimated annual savings are \$310. This is a partial award pending a final 12-month review.
Caroline L. Steyers	Building Inspection	\$ 35	Ms. Steyers is a Building Technician II. She suggested that the Annual Continuing Demolition Bond Form be revised. This is expected to save \$110 annually in printing and processing costs.
Edward C. Pease	Water Utilities	\$ 25	Mr. Pease is a Chemist in the Quality Division. He suggested that mirrors be installed at a blind intersection at the Miramar Filtration Plant. This was considered to be a significant safety improvement.
