Barry K. Wagner	Fire	\$ 25	Mr. Wagner is a Fire Fighter. He suggested that all engine companies be equipped with monitor nozzles. This will shorten set-up time and provide a more efficient operation.
William C. Middleton	Fire	\$ 20	Mr. Middleton is a Fire Fighter. He suggested that facepiece pouches for breathing gear be added to turnout coats. Pouches will be added to the breathing apparatus harness. This was considered to be a significant safety improvement.
Carl W. Harry	Property	\$ 10	Mr. Harry is an Associate Property Agent. He suggested that the Print Shop distribute Printing Services Requests on site in cases of emergency. Savings could not be calculated, but this was considered to be a significant operational improvement.
