A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO CERTIFYING THE NEGATIVE DECLARATION WITH RESPECT TO THE PROPOSED FIRST AMENDMENT TO THE REDEVELOPMENT PLAN FOR THE COLUMBIA REDEVELOPMENT PROJECT

WHEREAS, a Negative Declaration with respect to the proposed First Amendment to the Redevelopment Plan for the Columbia Redevelopment Project has heretofore been prepared and circulated for comment pursuant to the California Environmental Quality Act of 1970 (CEQA), and State and local regulations and guidelines adopted pursuant thereto; and

WHEREAS, a duly noticed public hearing was held on said Negative Declaration by the Redevelopment Agency of the City of San Diego on July 22, 1980, at which time all persons were given an opportunity to be heard; and

WHEREAS, the Redevelopment Agency of the City of San Diego, on July 22, 1980, certified that the Negative Declaration for the proposed First Amendment to the Redevelopment Plan for the Columbia Redevelopment Project was prepared and completed in compliance with said Act and State and local regulations and guidelines adopted pursuant thereto; and

WHEREAS, the Redevelopment Agency of the City of San Diego further certified on July 22, 1980, that the information contained in the Negative Declaration for said Project has been reviewed and considered by the members of the Agency Board; and

WHEREAS, the Redevelopment Agency of the City of San Diego, on July 22, 1980, found and determined that said proposed First Amendment to the Redevelopment Plan will not have a significant effect on the environment.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of San Diego as follows:

Section 1. This City Council hereby certifies that the Negative Declaration (with Secondary Study attached) with respect to the proposed First Amendment to the Redevelopment Plan for the Columbia Redevelopment Project has been prepared and completed in compliance with the California Environmental Quality Act of 1970 (CEQA), and State and local regulations and guidelines adopted pursuant thereto.

Section 2. This City Council hereby further certifies that the information contained in the Negative Declaration (with Secondary Study attached), together with any comments and responses thereto, and the previously prepared environmental documents for the Columbia Redevelopment Project has been reviewed and considered by the members of the City Council.

Section 3. This City Council hereby finds and determines that the proposed First Amendment to the Redevelopment Plan for the Columbia Redevelopment Project will not have a significant effect on the environment.
