

RESOLUTION No. R-252351 (R- 81-46 )


Adopted on JUL 28 1980

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that Street Easement Deed of GOOD SAMARITAN CHURCH OF SAN DIEGO, a California corporation, executed in favor of The City of San Diego, bearing date of June 1, 1980, conveying to said City the permanent easement and right-of-way for a public street and incidents thereto, over, under, upon, along and across all that portion of Quarter Section Lot 27 of Rancho De La Nacion, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and Parcel 1 is hereby named SKYLINE DRIVE, and Parcel 2 is hereby named WOODBINE WAY.

That the City Clerk is hereby authorized and directed to cause said deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
