BE IT FURTHER RESOLVED, that said portion of Section 27, Township 18 South, Range 2 West, S.B.M. is hereby dedicated as and for a public street, and the same is hereby named MADDEN AVENUE.

BE IT FURTHER RESOLVED, that the expenditure of not to exceed \$450.00 from CIP52-010.2, Coronado Avenue, for acquisition costs and related expenses, is hereby authorized and approved.
