WHEREAS, on June 9, 1980, Council authorized the City Manager to execute agreements with community agencies to operate 18

Revenue Sharing and 2 Community Development Block Grant (CDBG) social service programs during FY 1981; and

WHEREAS, at that time, contract negotiations had not been completed for two additional Revenue Sharing and two CDBG programs pending Council's approval of FY 81 funding levels; and

WHEREAS, at the same meeting, Council allocated funds to these additional programs, and the City Manager is now requesting authorization to execute the FY 81 agreements; and

WHEREAS, the additional allocations will increase the total FY 81 Revenue Sharing allocation for City operated (SIP) and contractual programs to \$1,288,338 and will increase the total CDBG allocation for contractual programs to \$702,615; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager be, and he is hereby authorized to execute, for and on behalf of said City, a FIRST AMENDMENT TO AGREEMENT with the San Ysidro Elementary School District, for the purpose of providing contractual services in regard to Economic Opportunity training for preschool and kindergarten through eighth grade students, for the period July 1, 1980 through June 30,

1981, in a sum not to exceed \$130,291, all pursuant to the terms and conditions of the FIRST AMENDMENT TO AGREEMENT on file in the Office of the City Clerk as Document No. 16252359.
