

BE IT RESOLVED, by the City Council of the City of  
San Diego as follows:

1. That the disbursement to the Redevelopment Agency of \$1,746,000 from Fund No. 10227, Contributions to the Redevelopment Agency, be made for the purpose of providing funds for assembly of the Parking Site.

2. That this disbursement from the City to the Redevelopment Agency is an advance of funds from CIP 52-286 (Public Improvements in the Marina/Columbia Residential Project) and CIP 52-0203.1 (Harbor Drive Realignment) to be repaid to the City within Fiscal Year 1981 from Horton Plaza disposition proceeds and proceeds from the second issue of Horton Plaza Lease Revenue Bonds.
