Said Council hereby finds that that certain map surveyed
by GLENN R. FERGUSON, a Licensed Land Surveyor, entitled
"PARADISE GARDENS WEST UNIT NO. 7 Being a subdivision of
Parcel 1 of Parcel Map No. 9715, in the City of San Diego,
County of San Diego, State of California, filed in the
office of the County Recorder of San Diego County,
February 19, 1980.," is made in the manner and form
prescribed by law and conforms to the surrounding surveys;
that said map and the subdivision of land shown thereon
is hereby approved and accepted; and said Council hereby
accepts on behalf of the public, the following: Blanford
street, Duarte Place and Hauser Street for public purposes,
and said streets are hereby declared to be public streets
and dedicated to the public use.

The Clerk of said City is hereby authorized and
directed to endorse upon said map, as and for the act of
the Council, that said Council has approved said subdivision
map and that said public streets are accepted on behalf of
the public as heretofore stated.


