

RESOLUTION No. R- 252403 (R- 81-92)



BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of those easement deeds of BOBBY J. BIRTS and RUBY ELIZABETH BIRTS, Trustees of the "Birts 1978 Family Trust" dated March 21, 1978, executed in favor of The City of San Diego, conveying to said City easements for flowage, storm drain and public street purposes over, along and across a portion of acre Lot 3 of Sorrento Lands and Townsite, according to Map thereof No. 483, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed for a public street is hereby dedicated as and for a public street and the same is hereby named SORRENTO VALLEY ROAD.

That the City Clerk is hereby authorized and directed to cause said deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
