That the expenditure of \$10,000 is hereby authorized from C.I.P. 22-039, General Landscaping, Capital Outlay Fund 30245 of The City of San Diego, solely and exclusively for the purpose of providing miscellaneous improvement of landscaping in Mission Bay Park.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and empowered to do by City forces the necessary work for miscellaneous improvement of landscaping in Mission Bay Park, pursuant to recommendation of the City Manager and submission of estimates by him indicating that said work can be done by City forces more economically than if let by contract.
