WHEREAS, the Planning Commission held public hearings on February 28, 1979, to consider the proposed "Fay Avenue Plan" prepared by La Jollans Inc. Fay Avenue Subcommittee and the City Planning Department under the direction of the City Council; and

WHEREAS, the "Fay Avenue Plan" was developed with the overriding objectives for preserving the existing residential character yet accommodating a population increase and retaining the low and moderate income housing facilities, maintaining a transportation corridor reservation, maintaining the socially and economically diverse community, accommodating needed community park facilities and enhancing the physical and social environment; and

WHEREAS, the Planning Commission approved and recommended to the City Council adoption of the "Fay Avenue Plan" and further recommended that this plan be incorporated into the La Jolla Community Plan and Local Coastal Program; and

WHEREAS, the Council of The City of San Diego held a public hearing to consider the "Fay Avenue Plan;" NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:
