BE IT RESOLVED, by the Council of The City of San Diego as follows:



BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to issue one check in the total amount of \$75,000.00 made payable to CLERK OF SUPERIOR COURT, in full settlement of the lawsuit and of all claims.
