That the bid of MOORE MAINTENANCE CORP. is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing COMPLETE CLEANING MAINTENANCE OF CENTRE CITY WAY as may be required for a period of twelve (12) months beginning August 1, 1980 through July 31, 1981 at a cost of \$1,732.32 per month for a total cost of \$20,787.84; terms 1% 10 days with an option to renew contract for two (2) additional twelve (12) month periods with escalation not to exceed 12% for each of the option periods.
