as follows:

Said Council hereby finds that that certain map surveyed
by CHARLES W. CHRISTENSEN, a Registered Civil Engineer, entitled
"PINETREE Being a subdivision of Lot 1 of Pinetree Hills,
in the City of San Diego, County of San Diego, State of
California, according to Map thereof No. 6807, filed in the
office of the County Recorder of San Diego County, December 17,
1970.," is made in the manner and form prescribed by law and
conforms to the surrounding surveys; that said map and the
subdivision of land shown thereon is hereby approved and
accepted.

BE IT FURTHER RESOLVED, that said Council hereby accepts
on behalf of The City of San Diego, a municipal corporation,
the open space easement over a portion of Lot 1, as granted
and shown on said map and subject to the conditions set
forth thereon.

The Clerk of said City is hereby authorized and directed
to endorse upon said map, as and for the act of the Council,
that said Council has approved said subdivision map and that
the easement for open space, as granted and shown on this
map, is accepted on behalf of The City of San Diego, a
municipal corporation, as above stated.


