

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a contractual agreement with the SAN DIEGO HOUSING COMMISSION for the purpose of administering the 1980 CDBG Low-Income Housing Planning and Development Project, for a term commencing July 1, 1980, and ending June 30, 1981, for a total compensation of \$185,000 to be paid to Commission, under the terms and conditions set forth in that contractual agreement on file in the office of the City Clerk as Document No. RC 252431 .

BE IT FURTHER RESOLVED, that the transfer of \$185,000 from Sixth Year CDBG Fund 18516 Element 5972 is hereby authorized, subject to HUD's approval of the Request for Release of Funds, for said services and related costs.


