

RESOLUTION NO. R-252438

WHEREAS, Enns & Gage, a partnership, was awarded the contract authorized by Council Resolution No. 250493, adopted October 29, 1979, for the construction of Mesa Viking Neighborhood Park - Phase III; and

WHEREAS, Enns & Gage began work pursuant to this contract on or about February 9, 1980 and ceased work on or about February 27, 1980; and

WHEREAS, Enns & Gage has informed the City that it is unable to complete its contract with the City; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That Enns & Gage, a partnership, is hereby declared to be in default under the terms of its contract with the City.

2. That the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for construction of Mesa Viking Neighborhood Park - Phase III, San Diego, California, filed in the office of the City Clerk of the City of San Diego, California, on August 1, 1980, and bearing official Document No. A-00115, be, and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Council has ascertained the current or prevailing rate of per diem wages paid by private employers in the City for each craft or type of workman or mechanic

needed to execute the contract, and does hereby declare that the wage scale included in said specifications is the said current or prevailing rate for the various crafts therein mentioned.

BE IT FURTHER RESOLVED, that the Purchasing Agent of The City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible and reliable bidder for construction of Mesa Viking Neighborhood Park - Phase III.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$63,910, from Park Service District 11222 Funds of The City of San Diego is hereby authorized, solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
