BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a ten (10) year Lease Agreement and Amendment 1 thereto, leasing to the U.S. DEPARTMENT OF IMMIGRATION AND NATURALIZATION, U. S. BORDER PATROL, office space in Building 1220, Brown Field Airport, at a monthly rental of \$1,890.00, under the terms and conditions set forth in that Lease Agreement and Amendment 1 on file in the office of the City Clerk as Document No. RR- 252465.

BE IT FURTHER RESOLVED, that the appropriation of \$68,500.00 from the Capital Improvements Program to be expended for costs of reconstruction of Building 1220, Brown Field Airport, said \$68,500.00 to be reimbursed in the form of an additional monthly rental payment amortized at 12% over the first 5-year period of said Lease Agreement, is hereby authorized and approved.
